Dear Brother Short:

For your information I am listing the various meetings so that you will be informed as to our plans.

It should be pointed out that the membership list of the Righteousness by Faith Committee as voted by the General Conference Committee does not contain the names of Brethren Wieland and Short. However, our meeting centers around the manuscripts and other documents that you brethren have presented at different times and we are, therefore, grateful that you can be with us for the meetings indicated below.

The members of the Task Force with certain others present will meet at 3:00 o'clock Sunday afternoon in C-2 of the General Conference building, and to this we are inviting you both. The purpose of this meeting is to give Brother Short an opportunity of presenting the historical material which was sent over back in September but which did not arrive in time for the study committee.
